Individual vs Institutional Capacity

Technical training does not necessarily translate into institutional capacity

- Challenge of incentives (incentives to train and then ...)
- Using technical capacity (how is learning used and transferred in an organisation, how is learning assessed, learning by doing)
- Professional capacity (analytical skills, writing, presentation, management skills....,)
- Institutional processes and procedures (training priorities, decisions about who is trained, for what and what happens after training – skills transfer, skill retention) – transparency, predictability, career pathing, lack of strategy (offers of training cannot be turned down?), institutional record....

More Lessons

- Institutional Coordination (New Trade Agenda new players)
- External Impetus for Institutional Development (eg establishment of institutions trade forum)
- Attorney General's Office (centralised model)
