

TIPS NEWSLETTER NOVEMBER 2016

This newsletter reports on some of our research projects and provides details of research published.

It also looks at some of the conferences and events with which TIPS has been involved.

RESEARCH PROJECTS

TRADE AND INDUSTRIAL POLICY PILLAR

Department of Trade and Industry

TIPS is working on several projects with the dti and continues to support some of the department's sector desks, including the automotive, agro-processing, chemicals, cosmetics and pharmaceuticals desks.

In the automotive sector, TIPS has been working on a project with B&M Analysts to support the dti with an automotive master plan that will contribute to the approach in developing the post Automotive Production and Development Programme (APDP) automotive incentive.

Current research for the agro-processing sector includes a review of abalone, a feasibility study on cassava for industrial uses, inputs into the Agricultural Phakisa and research on developmental food systems, among others. In chemicals, TIPS is supporting the identification of priority interventions, and it continues to support the other sector desks with data and research advice.

Manufacturing Circle

TIPS has established a partnership with the Manufacturing Circle. Following discussions with a number of stakeholders, the Manufacturing Circle Quarterly Bulletin has been replaced with the Manufacturing Circle Investment Tracker. This new survey aims to track investment in manufacturing and assesses specific measures of investment, namely, capital expenditure, working capital and employment.

This weighted composite index is designed as early warning system for assessing the status of the manufacturing sector. The findings of the survey are released to the public and presented at a TIPS Development Dialogue.

Steel task team

TIPS provided support to the Steel Task Team. This included undertaking and commissioning research, including:

- 1. A briefing note on the extent of the steel crisis.
- 2. Iron and steel sector mapping report.
- 3. Steel and waste management in South Africa.
- 4. Research and research capacity in the steel sector.
- 5. Analysis of investments into the steel value chain.
- 6. Steel and climate change, including carbon tax.
- 7. An economy-wide model on the multiplier impact of the steel sector.
- 8. A briefing note on the electricity and steel sectors.

TIPS contracted Vernon Harvey to provide project management support for the Steel Task Team and Paul Jourdan to provide expert support. TIPS provided project management and also played the role of secretariat, working with the relevant departments and entities — the dti, Economic Development Department, National Treasury and the Industrial Development Corporation (IDC) — to identify priority interventions and areas that needed to be unblocked to stave off the worst of the global steel crisis. There remain massive challenges facing the industry, including the downstream companies, which face tough competition.

Trade & Industrial Policy Strategies (TIPS) is a not-for-profit economic research organisation based in Pretoria, South Africa. TIPS has three main focus areas: trade and industrial policy, sustainable growth, and inequality and economic inclusion. TIPS undertakes research and analysis, and facilitates policy development, dialogue and capacity building.

Industrial Development Research Programme

TIPS is providing support to roll out a research programme on industrial development issues gripping the country. This project is being undertaken in partnership with the dti and the United Nations Development Programme.

National Economic Development and Labour Council (NEDLAC)

Over the past few years TIPS has undertaken several research projects for NEDLAC, and has presented to NEDLAC Chambers and partnered with NEDLAC on jointly hosting a Development Dialogue. Currently TIPS is completing a research paper for NEDLAC that looks at SA-US trade relations now that AGOA has been concluded.

ECONOMIC INCLUSION PILLAR

Department of Planning, Monitoring and Evaluation (DPME) in the Presidency

Government is implementing the Socio-Economic Impact Assessment System (SEIAS) as a method to review proposed legislation, looking at planned as well as unintended consequences. The approach is intended to strengthen new legislation and take social and economic factors into consideration. SEIAS was adopted by Cabinet as a requirement for new legislation. TIPS has been providing support to DPME, which is co-ordinating the programme and is helping develop a Community of Practice to support implementing the new system effectively.

Employment Partnership Programme

Small and Medium Enterprises (SMEs) play an important role in the South African economy as drivers of economic growth, innovation and job creation. TIPS is working with the Employment Partnership Programme (EPP) to undertake a study on Reducing the Administrative Burden for Small Businesses. This research builds on a strong body of knowledge already developed on the challenges facing small business, and the project is being done in collaboration with the Department of Small Business Development (DSBD). This research aims to assist the DSBD to develop a framework to systematically determine the intended or unintended consequences of national regulations on small business and identify ways to mitigate them.

SUSTAINABLE GROWTH PILLAR

Green economy project for the Department of Trade and Industry

This project involved the development and design of instruments to better understand the implications of transition of South African industries towards a low-carbon economy for local industries. The project will inform the role of the dti in assisting local industries in understanding climate change considerations, coping with climate change-related regulations, and embarking on the transition towards a greener, more sustainable economy.

City of Johannesburg solar PV power

In partnership with WWF-South Africa, TIPS is assisting the City of Johannesburg (CoJ) and City Power with a research project to look at how the city can use more solar PV power. TIPS and WWF are conducting a regulatory, policy, technical, financial and institutional review of all possible options for CoJ and City Power to increase the role of solar PV power in the municipality.

Partnership for Action on Green Economy

TIPS is conducting a green trade and industry analysis under the United Nations-led Partnership for Action on Green Economy (PAGE), with the aim of identifying and unlocking new, green manufacturing opportunities.

Green economy transition

Under the auspices of the Green Economy Coalition (GEC), TIPS, in collaboration with the Cape Townbased African Centre for a Green Economy (Africege), initiated a three and a half year process to unpack and debate the features and the management of the transition to a green economy in South Africa.

Green jobs

In partnership with WWF-SA, TIPS is hosting a dedicated Senior Researcher: Green Jobs for an initial period of two years with the aim of better understanding and unlocking green employment opportunities in South Africa.
